

**SECOND AMENDMENT TO
STANDARD AGREEMENT NO. MH-20-012,
AMENDMENT NO. MH-20-012-A01, PA NO. 21-68**

This second Amendment to Agreement No. MH-20-012 is entered into this 6TH day of APRIL, 2021, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and **Action Network Family Resource Center**, hereinafter referred to as "CONTRACTOR".

WHEREAS, Agreement No. MH-20-012 was entered into on July 1, 2020; and

WHEREAS, Amendment No. MH-20-012-A01, PA No. 21-68 was entered into on November 4, 2020; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original Agreement No. MH-20-012 from December 31, 2020 to June 30, 2021; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the amount set out in Amendment No. MH-20-012-A01, PA No. 21-68 from \$42,181.25 to \$86,843.75; and

WHEREAS, the Exhibit A - Definition of Services, and the Exhibit B - Payment Terms have been revised; and

WHEREAS, CONTRACTOR will provide Community Services and Supports and continue to provide Prevention and Early Intervention Services as part of the Mental Health Services Act.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in original Agreement No. MH-20-012 will be extended from December 31, 2020 to June 30, 2021.
2. The amount set out in Amendment No. MH-20-012-A01, PA No. 21-68 will be increased from \$42,181.25 to \$86,843.75.
3. The Exhibit A - Definition of Services in Amendment No. MH-20-012-A01, PA No. 21-68 has been altered and a new Exhibit A is attached herein.
4. The Exhibit B - Payment Terms in Amendment No. MH-20-012-A01, PA No.

21-68 has been altered and a new Exhibit B is attached herein.

All other terms and conditions of Agreement No. MH-20-012 and Amendment No. MH-20-012-A01, PA No. 21-68 shall remain in full force and effect.

EXHIBIT A

DEFINITION OF SERVICES

CONTRACTOR shall provide services that meet the criteria for Mental Health Services Act (MHSA) Community Services and Supports (CSS) Parent Partner Program and two Prevention and Early Intervention (PEI) services, one that increase access and linkage to treatment and one that reduces stigma and discrimination towards mental illness. Services shall create and facilitate a peer provider program through Point Arena Schools in accordance with the current Mental Health Services Act Plan. Services shall be provided in the home, CONTRACTOR's office, or community setting. CONTRACTOR shall provide the services with the intent of reducing stigma related to mental health services for and improving attitudes, beliefs, and perceptions about being diagnosed with a mental illness. CONTRACTOR shall provide the services with the intent of improving timely access to mental health services for underserved populations, specifically the Latino and Native American populations on the south coast, including the communities of Gualala, Point Arena and surrounding areas.

I. Parent Partner Program. CONTRACTOR shall:

- A. Conduct services in a way that meets the PEI Prevention category of the MHSA, to help prevent mental illnesses from becoming serious, severe and persistent, and to reduce risk factors and build protective factors, as further described in this Exhibit.
 - a. **School Based Peer Support Programs - Point Arena:** The project effectively responds to early signs of mental illness through collaboration between a mental health contract provider and the Point Arena School District (PASD) to provide early intervention services to students at PASD. Through school and classroom based groups, para professionals supervised by a clinical supervisor provide education, peer counseling, crisis counseling, family support, and referrals to identified programming. By providing services in the school setting, the program both allows for reduction of stigma related to being sent out of the classroom for services, as well as normalizing wellness and recovery.
 - b. **Target Population:** PASD has the capacity to serve up to sixty (60) students from ages eleven (11) to seventeen (17) in Point Arena Schools. This program will serve Children and Transition Aged Youth.
 - c. **Services Provided:** Youth workers screen students and utilize the Brief Screening Survey to assist the mental health contract provider to help reduce stigma and discrimination by providing educational and wellness services in the school setting to normalizing wellness and

self-care as relate to seeking services. A one-hour presentation to school staff and school counselors provides for the purpose of educating staff and improving the utilization of the screening tool. Youth workers also provide individual and group services to students under the supervision of a clinical supervisor.

d. **Program Goals:** Reduce negative perception of mental illness and/or discrimination for youth in PASD.

e. **Program Evaluation Methods:** The program staff conducts evaluation activities that meet the PEI requirements. The program shall provide the County with at least the following data:

- i. the number of screenings offered,
- ii. the number of screenings completed,
- iii. any change in screening results between quarters,
- iv. the number of referrals generated from screenings,
- v. the number of presentations,
- vi. the number of individuals attending each presentation,
- vii. where the presentations took place,
- viii. the target audience of the presentations
- ix. any other data demonstrating changes in attitude, stigma, and beliefs about mental illness

B. Recruit, train, support and monitor peers who will provide support to parents of children with mental illness. Services will be provided in the community or through family resource centers.

C. Utilize bicultural/bilingual parent partners, as needed.

D. Enable parent partners to support protective factors and link parents/families with resources, as needed, and provide family support, with priority given to those living in remote areas. Support will include assistance in accessing care, navigating systems, and encouragement for improving skills, developing social supports and managing their mental health concerns.

- E. Provide services through Family Resource Centers in Point Arena and Gualala to assist parents with applications for Cal-Fresh, Medi-Cal, or other benefit programs, and provide information on parenting classes and other available community resources.

II. Therapeutic Outreach, Access and Linkage. CONTRACTOR shall:

- A. Provide services in a way that meets PEI Access and Linkage category of the MHSA, as further described in this Exhibit.
- B. Provide outreach, engagement, and linkages to appropriate mental health services, targeting the Latino and Native American populations in the Gualala and Point Arena communities and surrounding areas of the south coast.
- C. Provide screenings and assessments to determine mental health needs. Services may include telephone help lines and mobile responses.
- D. Provide linkages to connect children, adolescents, adults and older adults with the first signs of mental illness, at risk of mental illness, or with severe mental illness to medically necessary care and treatment (including but not limited to care provided by the COUNTY mental health programs) as early in the onset of mental illness as is practicable.
- E. Provide referrals to therapeutic counseling, and to culturally specific treatment options as appropriate, including but not limited to: individual therapy, group therapy, traditional healing/spiritual interventions (including those that emphasize herbalist approaches), tele-psychiatry, Substance Use Disorder Treatment (SUDT) services, social services and supports, and Red Road.
- F. Utilize bilingual and culturally proficient staff, as needed.
- G. Develop brochures or marketing tools, in a format fit for public consumption, and provide the COUNTY with at least fifty (50) copies.
- H. Provide services in a way that takes into account particular needs of the underserved Latino and Native American tribal community members, and that are designed to improve timely access to mental health services. This may include considerations such as, but not limited to accessibility, transportation, hours available for service, cultural and language appropriateness, and culturally appropriate settings.

- I. Develop and utilize approaches that reduce stigma, self-stigma and discrimination related to being diagnosed with a mental illness, having mental illness or seeking services for mental illness.
 - J. Attend and participate in MHSA Forums. CONTRACTOR may be asked to highlight program areas and will be expected to answer questions as needed for the benefit of the Forum participants and the public in general.
 - K. Utilize an evidence based evaluation tool and a client satisfaction survey, for each individual and/or family member served, pre- and post-treatment/engagement.
- III. Stigma and Discrimination Reduction, School Based Peer Support Program- Point Arena. Contractor shall:
- A. Provide services in a way that meets PEI Stigma and Discrimination Reduction Program category of the MHSA plan, as further described in this Exhibit.
 - B. Provide a culturally congruent program that reduces negative feelings, and improves attitudes, beliefs, and perceptions about being diagnosed with a mental illness, having a mental illness, or for seeking mental health services. The program shall target services to students in Point Arena community and surrounding areas of the south coast.
 - C. Provide support to connect clients to specialty mental health services and other community supports as needed to meet mental health needs.
 - D. Provide linkages to connect children, and adolescents, with the first signs of mental illness, at risk of mental illness, or with severe mental illness, and their families to medically necessary care and treatment (including but not limited to care provided by the COUNTY mental health programs) as early in the onset of mental illness as is practicable.
 - E. Provide referrals to therapeutic counseling, and to culturally specific treatment options as appropriate, including but not limited to: individual therapy, group therapy, traditional healing/spiritual interventions (including those that emphasize herbalist approaches), tele-psychiatry, Substance Use Disorder Treatment (SUDT) services, and social services and supports.
 - F. Utilize bilingual and culturally proficient staff, where possible. All staff will take two trainings in cultural responsiveness skills per year.

- G. Develop brochures or marketing tools, in a format fit for public consumption, and provide the COUNTY with at least fifty (50) copies.
 - H. Provide services in a way that takes into account particular needs of the community that are designed to improve stigma, perceptions, and beliefs about access to and receiving mental health services. This may include considerations such as, but not limited to accessibility of services provided, transportation, hours available for service, cultural perceptions of mental illness, cultural and language appropriateness, and culturally appropriate settings.
 - I. Develop and utilize approaches that reduce stigma, self-stigma and discrimination related to being diagnosed with a mental illness, having mental illness or seeking services for mental illness.
 - J. Attend and participate in MHSA Forums. CONTRACTOR may be asked to highlight program areas and will be expected to answer questions as needed for the benefit of the Forum participants and the public in general. CONTRACTOR shall encourage program participants to attend and participate in MHSA forums to have their priorities, needs, and concerns heard.
 - K. Utilize an evidence based evaluation tool and a client satisfaction survey, for each individual and/or family member served, pre- and post-treatment/engagement.
- IV. CONTRACTOR shall complete the following reports separately for each of the above programs (Parent Partner Program Prevention, Therapeutic Outreach Access and Linkage, and Stigma and Discrimination Reduction Program) as outlined in MHSA PEI Regulation sections 3200.245, 3200.246 of Article 2, sections 3510.010, 3560, 3560.010, and 3560.020 of Article 5, and Article 7. Authority Cited: Section 5846, Welfare and Institutions Code, Reference: Section 5892, Welfare and Institutions Code. (See Prevention and Early Intervention Regulations attached to this contract. Attachment 2)

A. Annual Reports:

- 1. Funding Report: CONTRACTOR shall provide information on total funding sources, identifying the amount of funds received from Medi-Cal Federal Financial Participation, 1991 Realignment, Behavioral Health Subaccount, and any other funding source; the funding report covering the twelve (12) month period of this contract is due July 31, 2021.

2. Annual Summation Report: CONTRACTOR will provide an annual summary of services provided; the annual summation report covering the twelve (12) month period of this contract is due July 31, 2021, and is to include:
 - a) Summation of services provided, to whom (type of client), where the services took place, and how often services were provided.
 - b) A confidential list of client names to ensure unduplicated numbers.
 - c) Outcomes and indicators used by the program, what approaches were used to select specific indicators, and changes in outcomes and indicators as attributed to service delivery. CONTRACTOR will state how often the data is collected and analyzed.
 - d) An analysis of the strengths and challenges experienced by the CONTRACTOR in meeting prevention goals in the preceding year, which shall include a narrative of anecdotal information, with concrete examples, and/or quotes from participants, peer volunteers, and service providers that may be used to show effectiveness, and/or improve services.
 - e) Strategies used to avoid stigma among participants.
 - f) Strategies used to address cultural considerations.
 - g) A summary of any changes in the program from the beginning of the contract year to the end of the contract year.
- B. Twice Annual Reports: CONTRACTOR shall report the names of the staff conducting the MHSA Program, the fluent languages they speak, cultural proficiencies they have, and any cultural responsiveness training they have had during the reporting period. Reports are due within thirty (30) days of receiving the approved form from the COUNTY.
- C. Quarterly Program Reports: CONTRACTOR shall provide quarterly reports in accordance with Prevention and Early Intervention Regulations, Section 3560.010; Quarterly Program Reports are due forty-five (45) days following the last day of the quarter to which they pertain. CONTRACTOR shall report on:

1. The number of unduplicated clients and/or family members served with demographic information including:
 - a) Age.
 - b) Race.
 - c) Ethnicity.
 - d) Gender assigned at birth.
 - e) Gender identity.
 - f) Primary language used in home.
 - g) Sexual orientation.
 - h) Veteran's status.
 - i) Disability- which is not a result of severe mental illness, but includes physical, communication, health, or mental disability (including but not limited to a learning, or developmental disability).
 - j) The number of respondents who decline to answer any of the categories above.
2. The underserved population targeted for improvement of timely access to services.
3. What strategies were employed to promote access for the underserved population.
4. What strategies were utilized to avoid stigma.
5. Number of clients with Serious Mental Illness.
6. Total number unduplicated clients referred for treatment or other services.

- a) Indicate the type of treatment to which the individual was referred (specialty mental health services, prevention programs, early intervention programs, other programs or services).
7. Number of clients who followed through on referrals at least once.
8. Average interval between referral and participation to other services, and/or treatment, and the standard deviation.
9. Average duration of untreated mental illness measured by the interval between onset of symptoms (self-reported or family-reported) and engagement in treatment.
10. Description of the strategies the CONTRACTOR used to encourage access to services and follow through on referrals.
11. Summary of how the program reduced negative outcomes of mental illness.
12. Evidence Based Practices, Community Based Practice, or Promising Practice results, including:
 - a) What practice was used.
 - b) The outcomes of the practice used.
 - c) Standard deviation of outcomes.
 - d) Any trends in outcomes.
13. Client Satisfaction and/or other survey results which capture:
 - a) Reduced time between referrals and connection to services.
 - b) Reduced negative outcomes or prolonged suffering (which could include: suicide risk, incarceration, school failure, unemployment, homelessness, removal of children from the home).
 - c) Changes in attitudes, knowledge and/or behavior related to seeking mental health services.

- d) Impact of the program on community systems such as education, physical health care, social services, or other services.
- e) Other additional relevant indicators that are applicable to the program.

V. CONTRACTOR agrees to require all its employees and subcontractors' employees to comply with the provisions of Section 10850 of the Welfare and Institutions Code and Division 19000 of the State of California, Department of Social Services, Manual of Policies and Procedures, to ensure that:

- A. All applications and records concerning an individual, made or kept by any public officer or agency in connection with the administration of any provision of the Welfare and Institutions Code relating to any form of public social services for which grants-in-aid are received by this State from Federal Government, shall be confidential and shall not be open to examination for any purposes not directly connected with the administration of such public social services.
- B. No person shall publish or disclose, or use or permit, or cause to be published, disclosed, or used any confidential information pertaining to an applicant or recipient.
- C. All of its employees, agents, subcontractors, and partners are informed of the above provisions and that any person who knowingly or intentionally violates the provisions of said State law is guilty of a misdemeanor.

VI. CONTRACTOR and subcontractors agree to provide a system that complies with the COUNTY's Issue Resolution policy and procedure through which recipients of service shall have an opportunity to express and have considered their views, issues, and concerns regarding the delivery of services.

VII. CONTRACTOR and all subcontractors shall ensure that all known or suspected instances of child or elder abuse or neglect are reported to the child protective or adult services accordingly per Penal Code Section 11165(k) and Welfare and Institutions Code 15610. All employees, consultants, or agents performing services under this Agreement, who are required by Penal Code Section 11166 or Welfare and Institutions Code Section 15630 and 15632 to report abuse or neglect, shall sign a statement that he or she knows of the reporting requirements and shall comply.

VIII. CONTRACTOR and all subcontractors in performing services under this Agreement shall observe and comply with all applicable laws, ordinances, codes,

and regulations of governmental agencies, including federal, state, and all local governing bodies, having jurisdiction over the scope of services, including all applicable provisions of the California Occupational Safety and Health Act. CONTRACTOR shall indemnify and hold harmless from any and all liability, fines, penalties, and consequences from any of CONTRACTOR's failures to comply with such laws, ordinances, codes and regulations.

- IX. CONTRACTOR shall cooperate timely and fully with any utilization review committee established by COUNTY for the purpose of monitoring the accomplishments and effectiveness of CONTRACTOR and specific services provided to individuals.
- X. CONTRACTOR shall not be allowed or paid travel expenses unless set forth in the Agreement.
- XI. CONTRACTOR shall notify COUNTY of all communications with Media, including, but not limited to, press releases, interviews, articles, etc. CONTRACTOR shall not speak on behalf of COUNTY in any circumstances with Media, but is encouraged to describe the services it provides and respond to questions about those services. CONTRACTOR is also encouraged, where appropriate, to provide timely and factual responses to public concerns.
- XII. In carrying out the Scope of Work contained in this Exhibit A, CONTRACTOR shall comply with all requirements to the satisfaction of the COUNTY, in the sole discretion of the COUNTY. For any finding of CONTRACTOR's non-compliance with the requirements contained in the Exhibit A, COUNTY shall within ten (10) working days of discovery of non-compliance notify CONTRACTOR of the requirement in writing. CONTRACTOR shall provide a written response to COUNTY within five (5) working days of receipt of this written notification. If the non-compliance issue has not been resolved through response from CONTRACTOR, COUNTY shall notify CONTRACTOR in writing that this non-compliance issue has not been resolved. COUNTY may withhold monthly payment until such time as COUNTY determines the non-compliance issue has been resolved. Should COUNTY determine that CONTRACTOR's non-compliance has not been addressed to the satisfaction of COUNTY for a period of thirty (30) days from the date of first Notice, and due to the fact that it is impracticable to determine the actual damages sustained by CONTRACTOR's failure to properly and timely address non-compliance, COUNTY may additionally require a payment from CONTRACTOR in the amount of fifteen percent (15%) of the monthly amount payable to CONTRACTOR for each month following the thirty (30) day time period that CONTRACTOR's non-compliance continues. The parties agree this fifteen percent payment shall constitute liquidated damages and is not a penalty. CONTRACTOR's failure to meet compliance requirements, as determined by COUNTY, may lead to termination of this contract by the COUNTY with a forty-five (45) day written notice.

- XIII. CONTRACTOR shall maintain compliance with California Code of Regulations Title 9, MHP contract, California Code of Regulations Title 42, The Health Insurance and Accountability Act of 1996 (HIPPA) regulations, State and Federal laws, and other Mendocino COUNTY MHP requirements for client confidentiality and record security.
- XIV. Prior to terminating this Agreement, CONTRACTOR shall give at least forty-five (45) days written notice of termination to COUNTY.

EXHIBIT B

PAYMENT TERMS

COUNTY will pay CONTRACTOR as per the following instructions:

- A. For the period of July 1, 2020 through December 31, 2020 COUNTY will reimburse CONTRACTOR in an amount up to \$1,363.54 for the Parent Partner Program each month upon receipt of invoice for services as defined in the Definition of Services (Exhibit A). Payments for the Parent Partner Program shall not exceed \$8,181.24 from July 1, 2020 through December 31, 2020.
- B. For the period of January 1, 2021 through June 30, 2021 COUNTY will reimburse CONTRACTOR in an amount up to \$1,443.70 per month for the Parent Partner Program each month upon receipt of invoice for services as defined in the Definition of Services (Exhibit A). Payments for the Parent Partner program shall not exceed \$8,662.5 from January 1, 2021 through June 30, 2021.
- C. For the period of July 1, 2020 through December 31, 2020 COUNTY will reimburse CONTRACTOR in an amount up to \$2,125 for the Therapeutic Outreach, Access and Linkage Program each month upon receipt of invoice for services as defined in the Definition of Services (Exhibit A). Payments for Therapeutic Outreach Access and Linkage Program shall not exceed \$12,750 from July 1, 2020 through December 31, 2020.
- D. For the period of January 1, 2021 through June 30, 2021 COUNTY will reimburse CONTRACTOR in an amount up to \$2,250 per month for the Therapeutic Outreach Access and Linkage Program each month upon receipt of invoice for services as defined in the Definition of Services (Exhibit A). Payments for Therapeutic Outreach Access and Linkage Program shall not exceed \$13,500 from January 1, 2021 through June 30, 2021.
- E. For the period of July 1, 2020 through December 31, 2020 COUNTY will reimburse CONTRACTOR in an amount up to \$3,541.66 for facilitating the Peer Support program for Point Arena Schools, a Stigma and Discrimination category of the PEI program, each month upon receipt of invoice for services as defined in the Definition of Services (Exhibit A). Payments for Therapeutic Outreach Access and Linkage Program shall not exceed \$21,250 from July 1, 2020 through December 31, 2020.
- F. For the period of January 1, 2021 through June 30, 2021 COUNTY will reimburse CONTRACTOR in an amount up to \$3,750 for facilitating the Peer

Support program for Point Arena Schools, a Stigma and Discrimination category of the PEI program, each month upon receipt of invoice for services as defined in the Definition of Services (Exhibit A). Payments for Therapeutic Outreach Access and Linkage Program shall not exceed \$22,500 from January 1, 2021 through June 30, 2021.

- G. The COUNTY must receive all reports within thirty (30) days following the end of the period covered by the report, or as otherwise specified in Exhibit A.
- H. Failure for the COUNTY to receive any reports within the stated timeframes in this contract may influence the next payment to the CONTRACTOR.
- I. CONTRACTOR shall invoice COUNTY on an approved invoice monthly (Attachment 1). Invoice of services must be received by the 10th of the month for services rendered the previous month. Billing for services received after the 10th of the month will not be honored.
- J. COUNTY has up to thirty (30) days to reimburse CONTRACTOR for correctly submitted invoices for services provided by CONTRACTOR.

Payments under this Agreement shall not exceed Eighty-Six Thousand Eight Hundred Forty-Three Dollars and Seventy-Five Cents (\$86,843.75) for the term of the Agreement.
