

**AMENDMENT TO STANDARD SERVICES  
AGREEMENT NO. PA# 21-80**

This Amendment to Standard Services Agreement No. PA# 21-80 is entered into this 6<sup>TH</sup> day of APRIL, 2021, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and **1070 Hospitality LLC**, hereinafter referred to as "CONTRACTOR".

WHEREAS, Standard Services Agreement No. PA# 21-80 was entered into on November 6, 2020; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original Standard Services Agreement No. PA# 21-80, from March 5, 2021 to June 30, 2021; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to revise the Definition of Services, Exhibit A, and the Payment Terms, Exhibit B, set out in the original Standard Services Agreement No. PA# 21-80; and

WHEREAS it is the desire of CONTRACTOR and COUNTY to increase the amount set out in the original Standard Services Agreement No. PA# 21-80 from \$50,000 to \$60,000.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the original Standard Services Agreement No. PA# 21-80 will be extended from March 5, 2021 to June 30, 2021.
2. Exhibit A: The Definition of Services, Exhibit A, set out in the original Standard Services Agreement No. PA# 21-80 is revised to specify only provision of On Call Services beginning April 6, 2021, and is attached herein.
3. Exhibit B: The Payment Terms, Exhibit B, set out in the original Standard Services Agreement No. PA# 21-80 is revised to specify an hourly rate of pay beginning April 6, 2021, and is attached herein.
4. The maximum amount payable to CONTRACTOR set out in the original Standard Services Agreement No. PA# 21-80 is increased from \$50,000 to \$60,000.

All other terms and conditions of Standard Services Agreement No. PA# 21-80 shall remain in full force and effect.

### **PAYMENT TERMS**

Beginning April 6, 2021, COUNTY will pay CONTRACTOR per for the following instructions:

1. COUNTY will reimburse CONTRACTOR at the rate of \$100 per hour for services as outlined in Exhibit A.
2. CONTRACTOR shall submit monthly invoices for services provided the previous month. Invoices will detail hours, services, dates, and total amount to be paid.
3. Payments under this Agreement shall not exceed \$60,000 for the term of this Agreement.
