

RESOLUTION NO. 21-049

RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AUTHORIZING THE DEPARTMENT OF TRANSPORTATION TO ADVERTISE FOR BIDS AND AWARD DEPARTMENT OF TRANSPORTATION CONTRACT NUMBER 210021 FOR CONSTRUCTION OF THE SEISMIC RETROFIT OF BRIDGE NUMBER 10C0034 ON EUREKA HILL ROAD OVER THE GARCIA RIVER, COUNTY ROAD 505, MILEPOST 4.92, AT AN ESTIMATED COST OF \$1,556,500 (POINT ARENA AREA)

WHEREAS, the Mendocino County Department of Transportation (DOT) desires to seismically retrofit the existing concrete and steel bridge on Eureka Hill Road over the Garcia River, County Road (CR) 505, milepost (MP) 4.92; and

WHEREAS, the costs of construction for the retrofit of the existing bridge are estimated to be \$1,556,500, including contingency, and are anticipated to be paid for by the Federal Highway Administration (FHWA) Highway Bridge Program (HBP) with the local match funded through the Local Bridge Seismic Retrofit Account; and

WHEREAS, funding to accommodate construction costs has been budgeted through Budget Unit 3041 (Fiscal Year 2020/21 and Fiscal Year 2021/22); and

WHEREAS, under Section 20395 of the California Public Contract Code, the Board of Supervisors may authorize the Director of Transportation to execute contract change orders subject to certain cost limitations; and

WHEREAS, by Resolution 07-008, the Board of Supervisors authorized the Director of Transportation to execute changes to any DOT contract that exceeds \$250,000 by up to \$25,000, plus 5% of the amount of the original contract costs in excess of \$250,000, and in no event shall any change or alteration exceed \$150,000; and

WHEREAS, DOT has received authorization from FHWA to construct the project and recommends proceeding with the advertisement for bids and award of DOT contract No. 210021.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby:

1. Authorizes and directs the Director of Transportation to sign the Notice to Bidders inviting bids for DOT Contract No. 210021 for the seismic retrofit of the Eureka Hill Road Bridge over the Garcia River, CR 505, MP 4.92; and



The foregoing Resolution introduced by Supervisor Williams, seconded by Supervisor McGourty, and carried this 6th day of April, 2021, by the following vote:


