WHEREAS, it is the desire of CONTRACTOR and COUNTY to decrease the amount set out in BOS Agreement No. 19-195 from \$100,000 to \$31,000.

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in the original BOS Agreement No. 19-195 will be extended from March 31, 2021 to December 31, 2021.
- 2. The amount set out in BOS Agreement No. 19-195 will be decreased from \$100,000 to \$31,000.

All other terms and conditions of BOS Agreement No. 19-195 shall remain in full force and effect.
