

**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 19-018**

This Amendment to BOS Agreement No. 19-018 is entered into this 20TH day of APRIL, 2021, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Mendocino County Resource Conservation District, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 19-018 was entered into on March 27, 2019; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and Mendocino County Resource Conservation District, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the amount set out in BOS Agreement No.19-018 from \$840,900 to \$851,100.

NOW, THEREFORE, we agree as follows:

1. The amount set out in BOS Agreement No.19-018 will be increased from \$840,900 to \$851,100.

All other terms and conditions of BOS Agreement No. 19-018 shall remain in full force and effect.
