AMENDMENT NUMBER 15 TO BOARD OF SUPERVISORS AGREEMENT NUMBER 04-049, FRANCHISE AGREEMENT BETWEEN THE COUNTY OF MENDOCINO AND USA WASTE OF CALIFORNIA, INC., DBA EMPIRE WASTE MANAGEMENT, FOR SOLID WASTE COLLECTION AREA NUMBER TWO

This Amendment No. 15 to BOS Agreement No. 04-049 is entered into this 20th day of APRIL, 2021, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and USA Waste of California, Inc., dba Empire Waste Management, hereinafter referred to as "GRANTEE".

WHEREAS, BOS Agreement No. 04-049, Franchise Agreement Between the County of Mendocino and USA Waste of California, Inc., DBA Empire Waste Management, for Solid Waste Refuse Collection Area No. Two, herein after referred to as "Agreement", was entered into on May 11, 2004; and

WHEREAS, Amendment 1 to BOS Agreement No. 04-049 (BOS Agreement No. 04-265A) was entered into on December 14, 2004, Amendment 2 (CAO Agreement No. 05-017) on February 16, 2005, Amendment 3 (BOS Agreement No. 05-246A) on October 18, 2005, Amendment 4 (CEO Agreement No. 05-255) on December 27, 2005, Amendment 5 (BOS Agreement No. 06-075A) on May 9, 2006, Amendment 6 (CEO Agreement No. 06-584) on December 28, 2006, Amendment 7 on January 7, 2008, Amendment 8 on August 26, 2008, Amendment 9 on December 23, 2008, Amendment 10 on June 14, 2011, Amendment 11 (BOS Agreement No. 04-049-A11) on August 23, 2011, Amendment 12 (BOS Agreement No. 04-049-A12) on February 12, 2013, and Amendment 13 (BOS Agreement No. 04-049-A13) on June 20, 2017, and Amendment 14 (BOS Agreement No. 04-049-A14) on August 18, 2020; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and GRANTEE, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, the termination date of the Agreement was extended to June 30, 2021, by Amendment No. 11 on August 23, 2011; and

WHEREAS, it is the desire of GRANTEE and COUNTY to extend the termination date set out in BOS Agreement No. 04-049, as subsequently amended, from June 30, 2021 to June 30, 2022; and

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in BOS Agreement No. 04-049, as subsequently amended, is extended from June 30, 2021 to June 30, 2022.
- 2. The January 1, 2021 annual cost of living rate adjustment set forth in Section 15(B) of the Agreement is waived by Grantee.
