

**RESOLUTION NO. 21-056**

**RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS APPROVING AMENDMENT NUMBER 2 TO BOARD OF SUPERVISORS AGREEMENT NUMBER 20-014/DEPARTMENT OF TRANSPORTATION AGREEMENT NUMBER 190028 WITH WYLATTI RESOURCE MANAGEMENT, INC., FOR LEACHATE MONITORING AND HAULING SERVICES FOR LAYTONVILLE AND CASPAR LANDFILLS (LAYTONVILLE AND CASPAR AREAS)**

WHEREAS, landfill leachate is currently collected from the leachate storage system and disposed of at the local wastewater treatment plants by outside vendors; and

WHEREAS, on February 25, 2020, the Board approved Board of Supervisors (BOS) Agreement Number (No.) 20-014/Department of Transportation (DOT) Agreement No. 190028 with Wylatti Resource Management, Inc., to haul leachate from Caspar and Laytonville Landfills for a not-to-exceed amount of \$70,000; and

WHEREAS, Amendment No. 1 to the Agreement provided for a ten percent increase for a revised not-to-exceed amount of \$77,000; and

WHEREAS more leachate has been generated this year than anticipated; and

WHEREAS, additional funds will be required to perform the necessary leachate hauling services through the end of this year's leachate generation period; and

WHEREAS, it is estimated that an additional \$50,000 will be sufficient funds to perform the services for the remaining term of the agreement, resulting in a revised not-to-exceed amount for BOS Agreement No. 20-014/DOT Agreement No. 190028 of \$127,000.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby:

1. Approves Amendment No. 2 to BOS Agreement No. 20-014/DOT Agreement No. 190028, with Wylatti Resource Management, Inc., for additional Leachate Monitoring and Hauling Services for Laytonville and Caspar Landfills; and
