

**AMENDMENT TO BOARD OF SUPERVISORS  
AGREEMENT NO. 20-155**

This Amendment to BOS Agreement No. 20-155 is entered into this 25<sup>th</sup> day of May, 2021, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and **Nuestra Alianza de Willits**, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 20-155 was entered into on November 17, 2020; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. 20-155, from May 31, 2021 to June 30, 2022; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the amount set out in the original BOS Agreement No. 20-155, from \$158,700 to \$491,912.50; and

WHEREAS, CONTRACTOR will continue to pilot the Promotores de Salud Program to engage the Spanish speaking community to provide COVID-19 prevention and outreach services.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the original BOS Agreement No. 20-155 will be extended from May 31, 2021 to June 30, 2022.
2. The amount set out in the original BOS Agreement No. 20-155 will be increased from \$158,700 to \$491,912.50.

All other terms and conditions of BOS Agreement No. 20-155 shall remain in full force and effect.
