

## RESOLUTION NO. 21-093

### RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AMENDING THE POSITION ALLOCATION TABLE PROVIDING THE NUMBER AND COMPENSATION OF OFFICERS, DEPUTIES AND EMPLOYEES IN THE VARIOUS OFFICES OF THE COUNTY OF MENDOCINO

WHEREAS, the Board of Supervisors has adopted Resolution No. 20-079 which sets forth the classifications, salaries, and number of personnel in the various County departments; and

WHEREAS, it is the desire of the Board of Supervisors to amend said resolution to meet the needs of County service; and

WHEREAS, the affected departments or agencies have agreed to incorporate the positions within their existing fiscal year budgets; and

WHEREAS, Human Resources conducted a classification study of classifications allocated to Air Quality Management District (AQMD); and

WHEREAS, the Civil Service Commission approved the title change of AQMD Program Coordinator to AQMD Administrative Coordinator and the addition of supervisory duties to the existing classification of Senior Air Quality Specialist at its May 19, 2021 meeting; and

WHEREAS, the classifications represented by Service Employee International Union (SEIU) are scheduled for a pay adjustment effective July 11, 2021, the salary of Senior Air Quality Specialist shall receive a pay adjustment necessary to maintain its pay at 15% above Air Quality Specialist.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby adopts the below actions and authorizes the Position Allocation Table of Resolution No. 20-079 to be amended accordingly:


