

**AMENDMENT TO BOARD OF SUPERVISORS  
AGREEMENT NO. 20-092**

This Amendment to BOS Agreement No. 20-092 is entered into this 22<sup>nd</sup> day of JUNE, 2021, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and GEO Reentry Services, LLC, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 20-092 was entered into on June 24, 2020; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. 20-092, from June 30, 2021 to June 30, 2022; and

WHEREAS, it is the desire of the CONTRACTOR and COUNTY to increase the total contract amount set out in the original BOS Agreement No. 20-092 from Eighty Four Thousand Dollars (\$84,000.00) to One Hundred Sixty Eight Thousand Dollars (\$168,000.00).

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the original BOS Agreement No. 20-092 will be extended from June 30, 2021 to June 30, 2022.
2. The total contract amount set out in the original BOS Agreement No. 20-092 will be increased from Eighty Four Thousand Dollars (\$84,000.00) to One Hundred Sixty Eight Thousand Dollars (\$168,000.00).

All other terms and conditions of BOS Agreement No. 20-092 shall remain in full force and effect.
