AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. 20-092

This Amendment to BOS Agreement No. 20-092 is entered into this 22 to day of June, 2021, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and GEO Reentry Services, LLC, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 20-092 was entered into on June 24, 2020; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and <u>CONTRACTOR</u>, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. <u>20-092</u>, from <u>June 30</u>, <u>2021</u> to <u>June 30</u>, <u>2022</u>; and

WHEREAS, it is the desire of the CONTRACTOR and COUNTY to increase the total contract amount set out in the original BOS Agreement No. 20-092 from Eighty Four Thousand Dollars (\$84,000.00) to One Hundred Sixty Eight Thousand Dollars (\$168,000.00).

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in the original BOS Agreement No. <u>20-092</u> will be extended from <u>June 30</u>, 2021 to <u>June 30</u>, 2022.
- 2. The total contract amount set out in the original BOS Agreement No. <u>20-092</u> will be increased from <u>Eighty Four Thousand Dollars</u> (\$84,000.00) to <u>One Hundred Sixty Eight Thousand Dollars</u> (\$168,000.00).

All other terms and conditions of BOS Agreement No. 20-092 shall remain in full force and effect.
