AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. <u>21-086</u>

This Amendment to BOS Agreement No. <u>21-086</u> is entered into this 14th day of September, 2021, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and <u>Colantuono</u>, <u>Highsmith & Whatley, PC</u>, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 21-086 was entered into on May 27, 2021; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and <u>Colantuono</u>, <u>Highsmith & Whatley</u>, <u>PC</u>, this document will become part of the aforementioned agreement and shall be incorporated therein; and

WHEREAS, the parties to this agreement desire that CONTRACTOR shall provide litigation legal services, advisory, and representation services to COUNTY and its officers and employees, in and with respect to the lawsuit *Ezekial Flatten, et al. v. Bruce Smith, et al.*, Mendocino County Superior Court Case No. 21CV00588, in addition to continuing representation of the County in the defense of the matter of *Anne Marie Borges, et al. v. County of Mendocino, et al.*, Northern District of California Case No. 3:30-cv-04537-SI; and; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total amount of the agreement by \$250,000 for a new total of \$300,000.

NOW, THEREFORE, we agree as follows:

- 1. The total amount of the agreement set out in the original BOS Agreement No. 21-086 will be increased by \$250,000 for a new total of \$300,000; and
- 2. CONTRACTOR shall provide litigation legal services, advisory, and representation services to COUNTY, its officers and employees, in and with respect to the lawsuit *Ezekial Flatten, et al. v. Bruce Smith, et al.*, Mendocino County Superior Court Case No. 21CV00588, in addition to continuing to provide a defense in the matter of of *Anne Marie Borges, et al. v. County of Mendocino*, et al., Northern District of California Case No. 3:30-cv-04537-SI.

All other terms and conditions of BOS Agreement No. <u>21-086</u> shall remain in full force and effect.
