

**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 19-182**

This Amendment to BOS Agreement No. 19-182 is entered into this 21st day of July, 2020, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and CHRISTIANA DARLINGTON, dba CLERE INC., hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 19-182 was entered into on July 9, 2019; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and CHRISTIANA DARLINGTON, dba CLERE INC, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. 19-182, from June 30, 2020 to June 30, 2021;

WHEREAS, it is the desire of the COUNTY to increase the original compensation of Forty Thousand Five Hundred Dollars (\$40,500) by Forty Thousand Five Hundred Dollars (\$40,500) for a new, not to exceed amount of Eighty One Thousand Dollars (\$81,000) for the term of this agreement.

NOW, THEREFORE, we agree as follows:

1. Term. The term of this Agreement shall commence upon execution and shall terminate on June 30, 2021.
2. The total compensation payable set out in the original Agreement No. 19-182 will be increased from \$40,500 to \$81,000.

The intent of this Amendment is to extend this contract until June 30, 2021, and increase total compensation payable to \$81,000, with no other changes.
