The Jail has two industrial sized washing machines and is required to do laundry daily for up to 300 inmates. One machine has a significant leak. Repair will cost almost as much as purchasing a new one (\$16k). The leak is posing a safety issue to staff and inmates and wasting water during a drought. Employees are using towels and blankets to prevent water from spilling onto the floor. Only one vendor sells/services this type of machine in our region. The other washer is the same brand. This expense can be absorbed in the JA 2510 budget by decreasing funds in Line Item 86-2232 (LE services & supplies).
