NOTICE IS HEREBY GIVEN THAT the Mendocino County Board of Supervisors at its regular meeting on Tuesday, October 19, 2021, at 9:00 a.m., in the Board of Supervisors Chambers, 501 Low Gap Road, Ukiah, California, will conduct a public hearing on the following project and the Draft Mitigated Negative Declaration (MND) at the time listed or as soon thereafter as the item may be heard.

Project title: Lambert Lane Bridge at Robinson Creek Replacement Project, County Bridge #10C0146.

Project location: The Project is located in the Town of Boonville, California on the western side of State Route 128 in the Anderson Valley Region on Lambert Lane at the crossing of Robinson Creek.

Description of project: The Mendocino County Department of Transportation (MDOT) proposes to replace the existing Robinson Creek Bridge on Lambert Lane, approximately 400 feet west of State Route (SR) 128. The existing structure is 32 feet long and 26 feet wide reinforced concrete bridge with closed strutted abutments founded on spread footings on erodible alluvial material. The replacement bridge will have 9-foot lanes and 5-foot shoulders in each direction resulting in a wider structure which meets safety standards. In addition to the bridge replacement, portions of the stream channel upstream and downstream of the bridge will be stabilized. Construction is expected to begin in summer 2022.

ENVIRONMENTAL DETERMINATION: The Mendocino County Department of Transportation has prepared a Draft Mitigated Negative Declaration for the above project (there will not be a significant effect in this case because proposed mitigation measures will reduce potentially significant effects to a less than significant level). Your comments regarding the above project and/or the Draft Mitigated Negative Declaration are invited. Written comments should be submitted to the Mendocino County Department of Transportation. All written comments **must be received prior to 5 P.M. September 30, 2021** to be included with the Staff Report to the Board. Oral, email and/or additional written comments may be presented to the Board of Supervisors during the public hearing.

If you challenge the above matter in Court, you may be limited to raising only those issues which you or someone else raised in the written correspondence delivered to the Department of Transportation, at or prior to the date indicated above. All persons are invited to appear and present testimony in this matter.


