Board Action: Upon motion by Supervisor McCowen, seconded by Supervisor Gjerde, IT IS ORDERED that the Board of Supervisors approves the FY 2018-19 Mendocino County Proposed Budget as recommended, and directs the Auditor-Controller to prepare the required documents for adoption of the FY 2018-19 Final Budget on June 19, 2018; and directs the Chief Executive Officer to create a Cultural Services Agency; directs staff to allocate \$90,000 from fund balance carryover to support fire agencies; keep Juvenile Hall open by utilizing \$253,000 of fund balance carryover; \$900,000 from an additional assumed 5% vacancy rate across General Fund Programs, and a \$125,000 reduction in the Probation/Juvenile Hall budget; Health and Human Services Agency will fund the homeless services day shelter with \$41,000 from existing funds; and staff shall return with funding options regarding Stepping Up Initiative. 


