Summary of Request:

Redwood Community Services, Inc. operates Mendocino County Children's Center, a group home for youth

ages 7 to 17 who present significant behavioral challenges that prevent placement in a home-based setting. This amendment will provide additional funding for increased staffing to meet the needs of Mendocino County Children's Center youth with significant special needs that require a higher level of care. This placement is temporary until Family and Children's Services secures a more suitable long-term placement either in or out-of-state.
