#### **Summary of Request:**

Mendocino County Youth Project (MCYP) provides various youth services for the community as well as incustody. Community services are provided to justice involved youth and at-risk middle or high school youth with no other funding service options. Services include early intervention, prevention, education, and direct counseling services to youth through various programs with the goal of maximizing opportunities for these

youth to lead productive, successful lives. In-custody services provide intervention, education and therapeutic services to youth housed in Mendocino County Juvenile Hall (MCJH) through programs such as Youth Success Coaching (individual and group) and Mental Health Therapy (individual, group, and family).

The availability of mental health professionals in our community has affected the types of services MCYP is able to provide. Working with MCYP to redefine available services and providers as they relate to the needs of Probation and Juvenile Hall, resulted in the contract being retroactive.
