# **Previous Board/Board Committee Actions:**

On June 6, 2023, the Board approved the first amendment to PA Agreement 20-133 that extended the

termination date to June 30, 2024 and increased the Agreement total by \$16,666.66 for a new Agreement total of \$66,666.66.

# **Summary of Request:**

On February 18, 2020, the Sheriff's Office released Request for Proposal (RFP) SO-2020-001 for Coroner and Pathology-Related Mortuary Services. Chapel by the Sea was awarded a three-year Agreement in the amount of \$50,000 for services performed within the Coastal Operations Sector of Mendocino County, with the option to extend the Agreement termination for two additional one-year periods. This second amendment will extend the termination date set out in BOS Agreement 23-093 from June 30, 2024, to June 30, 2025, and will increase the Agreement total by \$16,666.66 bringing the total maximum Agreement total to \$83,333.32.
