Approval of Retroactive Agreement with the City of Fort Bragg in the Amount of \$81,900, to Operate the Mendocino Coast Emergency Winter Shelter for Persons Experiencing Homelessness in Fort Bragg and the Coastal Region, Effective December 1, 2023, through March 31, 2024

#### **Recommended Action/Motion:**

Approve retroactive Agreement with the City of Fort Bragg in the amount of \$81,900, to operate the Mendocino Coast Emergency Winter Shelter for persons experiencing homelessness in Fort Bragg and the coastal region, effective December 1, 2023, through March 31, 2024; authorize the Social Services Director or designee to sign any future amendments that do not increase the maximum amount; and authorize Chair to sign same.

#### **Summary of Request:**

The proposed retroactive Agreement with the City of Fort Bragg is funded by the Homeless Housing, Assistance, and Prevention (HHAP) Grant Program to provide hotel-based non-congregate emergency shelter services to persons experiencing homelessness in the Mendocino coastal area during extreme weather

events. This population includes, but is not limited to, families with children under the age of 16, the elderly, and severely disabled individuals who are most at risk of the environmental conditions expected within the Agreement time period. The proposed Agreement is fully funded with grant funds and no General Fund dollars will be used.

This Agreement resulted from a formal Request for Proposal process implemented during the fall of 2023, using HHAP funding jointly administered by both the County and the Continuum of Care. The resulting proposals were approved by the CoC Board at their November 20, 2023. The need to obtain multiple points of approval from more than one governing body has led to a delayed implementation of the contract and subsequent retroactive status.
