#### **Summary of Request:**

The Board of Supervisors unanimously approved the Appointment of Mellisa Hannum during the Closed Session meeting on May 8, 2024. Mellisa was hired in December of 2021 as the Branch Library of the Point Arena branch. Mellisa successfully obtained her master's in library science in March of 2023. Mellisa will continue to oversee the Point Area branch as well as her new leadership role as Mendocino County Librarian.

The action today is to formally appoint Mellisa Hannum as the County Librarian and establish her starting salary.
