#### **Summary of Request:**

Zip Books provide patrons with quick access to print books, large-type books, and audiobooks which may not be available through the Library by providing funding for the books to be purchased and mailed directly to the patrons from a vendor. The patrons then return the books to the library, and they may be added to the collection and made available to others. This is a very popular program, and patrons look forward to it each
