On June 21, 2016, the Board approved agreement number 16-037 with Liebert Cassidy Whitmore. On June 20, 2017, the Board approved agreement number 17-043 with Liebert Cassidy Whitmore.

Summary of Request:

Investigation services require a specific agreement and must be independent from other contracted services with Liebert Cassidy Whitmore (LCW). A new and separate agreement to provide those services is submitted concurrently with this request therefore allowing a decrease to the total amount of Board of Supervisors Agreement Number 17-043 with LCW for employer-employee relations services.
