**Summary of Request:**

Mendocino County currently contracts with Redwood Community Services, Inc. (RCS) to provide shelter services and related resources to inland clients at the Building Bridges Homeless Resource Center, located at 1045 S. State St., Ukiah. These services address the needs of Mendocino County Department of Social Services (MCDSS) Adult Protective Services (APS) clients, as well as additional individuals in Mendocino

County who are experiencing homelessness and need to be sheltered. Through the proposed Agreement, RCS will provide beds, meals, shower and laundry facilities, phone access, mail delivery, other amenities, outreach, Housing Stability Plans, and case management to qualified individuals. Additionally, this site serves as a central hub for local service providers to provide direct services and refer clients for other appropriate services.

Funding from the Housing and Homelessness Incentive Program (HHIP) allocation to Mendocino County, through Partnership HealthPlan of California, will be used to support the services described in the proposed Agreement..
