Approve retroactive Agreement (first amendment to Agreement No. PA-23-54, MH-22-050) with Relias, LLC., to increase the amount by up to \$20,986.08, for a new total amount of \$59,062.08, to monitor and provide required annual training for all Behavioral Health and Recovery Services and Public Health staff, effective December 1, 2022, through November 30, 2025; authorize the Behavioral Health and Recovery Services director or designee to execute any Amendments that do not increase the maximum amount; and authorize Chair to sign same.

Summary of Request:

Relias, LLC. is a workforce education and enablement solutions provider based out of Morisville, North

Carolina. Relias offers comprehensive trainings, tracking services, automated compliance, and customized training plans services to help healthcare organizations stay in compliance with required staff training according to state and federal regulations. Additionally, Relias offers all required trainings in one platform and provides Continuing Education Units (CEU) to staff required to obtain CEUs to maintain current and active certifications and licenses.

Through Agreement No. PA-23-54, MH-22-050, Behavioral Health and Recovery Services (BHRS) has successfully utilized monitoring and training services from Relias since December 1, 2022. The proposed Amendment will incorporate Public Health (PH) into this Agreement, enabling PH staff to receive required regulatory annual trainings. This addition of PH users to the existing account will result in up to \$20,986.08 additional costs, for a new total maximum amount of \$59,062.08 for services for BHRS and PH staff through November 30, 2025. Once the proposed Amendment is executed it will be effective for the full term of the Agreement, from December 1, 2022 through November 30, 2025.

Due to the unforeseeable need to add PH users to the existing account, this Amendment was not anticipated. BHRS began processing the Amendment as soon as the need was recognized, and the Amendment is before the Board of Supervisors with a retroactive start date of December 1, 2022.
