Recommended Action/Motion:

Direct staff to initiate the steps needed to create a land use ordinance for commercial cannabis discretionary permits including the sunset of portions of 10A.17 and 20.242 within three years of adoption (or other determined date). Direct staff to close Phase 2 and transition Phase 1 and Phase 2 permittees and applicants to the new land use discretionary permitting process. Provide direction to staff on zoning, size and density allowances of cannabis cultivation. Direct Cannabis Program staff to prioritize responsibilities to focus on existing permit holders in Phase 1 and 2 who require an issued CEQA Checklist prior to the January 1, 2022 provisional end date with a cost recovery system identified.

Adoption of Ordinance No. 4381, adopting Chapters 10A.17 and 20.242 to the Mendocino County Code. Adoption of Ordinance No. 4392, making certain amendments to Chapter 10A.17. Adoption of Ordinance No. 4405, making modifications to Chapter 20.242. Adoption of Ordinance No. 4408, making additional amendments to Chapters 10A.17 and 20.242. Adoption of Ordinance No. 4411, making additional amendments to Chapter 10A.17. Adoption of Ordinance No. 4413, making additional amendments to Chapter 10A.17. Adoption of Ordinance No. 4420, making additional amendments to Chapters 10A.17 and 20.242 as well as adding Chapters 20.118 and 20.119 to County Code. Adoption of Ordinance No. 4422, making additional amendments to Chapters 10A.17 and 6.36. Adoption of Ordinance No. 4438, making additional amendments to Chapters 10A.17 and 20.242. Adoption of Ordinance No. 4463, making additional amendments to Chapter 10A.17. In addition to the Ordinances noted above, the Board has previously given direction to staff on consideration of a discretionary permit process for cannabis cultivation activities on May 14, 2019, December 10, 2019, February 25, 2020 and June 16, 2020.

Summary of Request:

On June 16, 2020, the Board of Supervisors gave direction to the Planning and Building Services Department to continue exploring options with the California Department of Food and Agriculture (CDFA) and the California Department of Fish and Wildlife (CDFW) to make the current system more functional, to continue processing permits through the current system, and also develop details on what moving in a land use specific direction would look like opposed to continuing with the current cultivation permitting system.
