Conduct a Community Forum in accordance with Government Code section 7283.1; receive report regarding County law enforcement agencies interaction and communications with ICE regarding access to individuals for civil immigration enforcement in 2017; and receive public comment.

**Summary of Request:**

The Transparent Review of Unjust Transfers and Holds (“TRUTH”) Act (Act) was signed into law on September 28, 2016. Beginning January 1, 2018, the Act requires local law enforcement agencies, prior to an interview between the ICE and an individual in custody regarding civil immigration violations, to provide the individual with a written consent form. The Act also requires that records related to ICE access be public records for the purposes of the California Public Records Act among other provisions.

The Act also calls for the local governing body of any county in which a local law enforcement agency has provided ICE access to an individual during the last year, to hold at least one public community forum during the following year. At that time, the local governing body must provide information to the public about ICE's access to individuals and receive and consider public comment with at least 30 days' notice. This public form is being held pursuant to that requirement. A public notice of the forum was posted in the Ukiah Daily Journal on November 4, 2018, meeting the 30 day notice requirement.
