By Resolution Number (No.) 18-199 (December 18, 2018) The Board of Supervisors authorized Department of Transportation (DOT) to advertise for bids and award five DOT contracts to perform 2017 Fire Damage Permanent Repairs on Various Potter Valley Roads including Eel River Road, County Road (CR) 240B; Main Street, CR 245; Hawn Creek Road, CR 245A; Gibson Lane, CR 246; Busch Lane, CR 247; North Busch Road, CR 247A; West Side Potter Valley Road, CR 248; and Powerhouse Road, CR 248A; and other contracts on various Redwood Valley Roads and Tomki Road which are not included in this contract.
