The MCSO Inmate Services Program is seeking a five (5) year Social Work Agreement with Humboldt State University, Department of Social Work, to allow undergraduate and masters in social work (MSW) students the ability to intern at the Mendocino County Jail. The Inmate Services Program Manager will identify and interview potential interns in collaboration with the University while adhering to all clearance and policy and procedures set forth by MCSO and the County. In our efforts to reduce recidivism and reintegrate criminal justice clients into society, it is essential that we offer high quality programming and service delivery. The benefit of having interns from undergraduate and graduate level programs is that we enhance our working relationships with local universities while introducing our inmate population to post-secondary educational opportunities.
