#### **Summary of Request:**

Mendocino County currently contracts with Mendocino Coast Hospitality Center (MCHC) to provide shelter services and related resources to clients on the coast, to address the needs of the Health and Human Services

Agency (HHSA) General Assistance (GA) clients and all of Mendocino County persons who are at risk of, or currently experiencing homelessness. MCHC provides beds, meals, shower and laundry facilities, phone access, mail delivery, other amenities, outreach, and housing assistance to qualified individuals.

MCHC will continue providing services through the proposed Amendment for Fiscal Year 2019-20, which includes new language as recommended by Dr. Robert Marbut, to better define services; increased funds for a one-time payment for shelter services; and increased funds for staffing from January 2020 through June 2020.
