Summary of Request:

As reported in the June 9 CEO Report, a clogged sewer line was identified in the County Jail Building 2 on

June 1. The technician responding to the service call found the line obstructed with bedding or clothing and was not able to clear with drain auger equipment. Ultimately, emergency repairs were required, and a contractor was hired to precisely locate the blockage, remove the slab, dig up the sewer line, cut out the pipe to remove the blockage, repair the pipe and refinish.
