# **Summary of Request:**

To expedite the use of CARES Act funds, the California Department of Housing and Community Development (HCD) has allocated all funds to jurisdictions that are eligible to receive COVID-19 funding. As such, Mendocino County has been allocated \$293,812 to provide assistance during the pandemic. This is a special short term grant, with a 12 month spending window, which has been designed to get funds out in the community quickly where they are needed most.
