Category Five Professional Consultants, Inc. was hired by the Mendocino Council of Governments (MCOG) on 10/25/19 to construct a Wildfire Vulnerability Assessment, an Emergency Preparedness Evacuation Plan and a Public Outreach Plan for Mendocino County. In developing the three plans, the consultants worked extensively with the County Fire Chief's Association, the Sheriff's Office and a Technical Advisory Group comprised of key community stakeholders.
