Recommended Action/Motion:

Introduce and waive reading of an Ordinance adding Chapter 2.39 creating a Public Safety Advisory Board.

Previous Board/Board Committee Actions:

On June 23, 2020, the Board of Supervisors created an *ad hoc* committee to explore the creation of a potential public safety advisory board. On September 1, 2020, upon the recommendation of the *ad hoc*, the Board of Supervisors directed County Counsel to prepare the necessary legal framework to establish a public safety advisory board.

Summary of Request:

On September 1, 2020, the Board of Supervisors directed County Counsel to prepare the necessary legal framework to establish a public safety advisory board. Per the recommendation of the *ad hoc* committee, the Board indicated that it desired certain powers, limitations, and composition of that committee. The proposed

ordinance has been drafted to conform with those directives and is the first step to establishing the necessary legal framework for this advisory body.
