Summary of Request:

The Mendocino County Planning Commission is presently composed of seven members. Each Supervisor

nominates an appointment and in addition there are seats for agricultural and forestry representatives. All appointments are confirmed by the BOS. Mendocino County is unique in that we have two industry appointments. Other industries are desiring representation on the Planning Commission. The Planning Commission would benefit from a more streamlined commission and a more workable quorum. To align our Planning Commission with other counties and give fair representation to all, the recommendation is to eliminate the two additional seats on the Planning Commission. With five seats on the Planning Commission, a quorum of 3 would be sufficient and a majority of two could move decisions.
