The U.S. DOJ DEA works with local law enforcement agencies regarding illicit cannabis eradication activities

on Federal lands within their jurisdiction. The funds are used to defray costs relating to the eradication and suppression of illicit cannabis. They are primarily intended for payment of deputies' overtime while those deputies are directly engaged in the illicit cannabis eradication process. The Agreement runs October 1, 2020 to September 30, 2021. The Sheriff's office received the agreement for processing on December 14, 2020 and therefore is being presented now for retroactive Board consideration.
