Approve amendment to Agreement 20-81 with Liebert Cassidy Whitmore (LCW), Effective February 23, 2021, Increasing the Total Compensation by \$150,000 (from \$200,000, for a New Agreement Total of \$350,000) for Litigation Services for *Grewal v County of Mendocino*; and authorize Chair to sign same.

Previous Board/Board Committee Actions:

The Board of Supervisors authorized the utilization of outside counsel on this litigation in closed session on February 4, 2020. The Board approved \$25,000 in additional funding on August 18, 2020 and \$125,000 in additional funding on September 1, 2020.

<u>Summary of Request:</u>

The County entered into a \$50,000 Purchasing Agent Agreement with Liebert Cassidy Whitmore (LCW) for litigation services for *Grewal v. County of Mendocino* on March 4, 2020. The Board approved \$25,000 in additional funding on August 18, 2020 and \$125,000 in additional funding on September 1, 2020. The billable

services are anticipated to exceed the amount of the agreement so an increase is being requested to cover continuing costs.
