#### **Recommended Action/Motion:**

Authorize award of a contract to Adams Commercial General Contracting, Inc. in an amount up to \$295,849.00 for the Behavioral Health Regional Training Center Remodel Project and any of the Alternate items included in the bid at the direction of the Board of Supervisors; authorize the Facilities and Fleet Division Manager to act as project manager to approve change orders for the project pursuant to Public Contract Code Section 20142; and authorize Chair to sign same.

#### Summary of Request:

On December 07, 2020, bids for the Behavioral Health Regional Training Center Remodel Project were opened; three bids were received and bid results are included in the board packet. Facilities and Fleet reviewed the bids, and, along with the Mental Health Citizen's Oversight Committee, recommends awarding a contract to Adams Commercial General Contracting, Inc. (ACGC), the lowest bidder.

The total maximum proposed award is \$295,849.00 (Two Hundred Ninety-Five Thousand Eight Hundred Forty-Nine Dollars). This is the maximum amount possible; the actual amount will consist of the base bid (\$168,267.00), plus any alternate items as decided by the Board of Supervisors, which include Alternate A (\$108,428) Fire Protection System, and/or one of either Alternate B (\$14,730) LED Lighting Retrofit/Partial Replacement or Alternate C (\$19,154) LED Lighting Retrofit/Full Replacement.

Based on this information, Measure B recommends approval by the Board of Supervisors to award a construction contract to ACGC, Inc. to complete the Behavioral Health Regional Training Center Remodel Project and to include Alternate C in the agreement. The recommendation from Measure B does not include Alternate A (\$108,428) Fire Protection System. As a County Building, a Fire Protection System would typically be included in these types of facility remodels. The cost for the Fire Protection System could be covered through Measure B or General Funds.
