A request for an Administrative Coastal Development Permit to construct a 2,198 ± Square Foot Single Family

Residence. The project includes an attached Garage, Fencing, Detached Greenhouse, Paved Driveway, Solar Power Generator, Installation of a Septic & Propane Tanks, and Connection to Utilities. Associated Development Includes the Removal of Eight Trees within the Building Envelope. The Coastal Development Permit was administratively approved by the Coastal Permit Administrator (CPA) on March 22, 2021 and requires the Board of Supervisors authorization for issuance of the permit.
