Approve retroactive second amendment to BOS Agreement No. 19-254 with West Business Development Center for economic recovery services in the additional amount of \$69,000, for a new total of \$266,000 extending the termination date from March 31, 2021 to December 31, 2021; and authorize Chair to sign same.

Previous Board/Board Committee Actions:

The Board approved the grant application for this project to the Economic Development Administration (EDA) at the June 19, 2018 meeting. The Board approved the original agreement at the November 11, 2019 meeting and approved the first amendment at the May 5, 2020 meeting.

Summary of Request:

Under the direction of the County, West Business Development Center oversees the development of a Mendocino County Economic Recovery and Resiliency Plan. The plan will create a strategic framework for the

activities and efforts of local governments, agencies, and organizations to create a resilient economy in Mendocino County.

This project is funded by the Economic Development Administration (EDA) through its Disaster Supplemental funding. EDA's period of performance for this project is April 1, 2019 to March 31, 2021. However, due to the delays of COVID-19, EDA has approved an extension for this project until December 31, 2021. This agreement is retroactive because the County could not execute the amendment before EDA approves the time extension-which occurred on March 31, 2021. This amendment will increase the contract amount from \$197,000 to \$266,000 to reflect the additional time West put into the project.
