**Summary of Request:**

The County has contracted with Abbott & Kindermann, Inc. to provide specialized legal services related to the CEQA issues involving the interface between the County's cannabis cultivation permitting system and state approvals by CDFA. While the County may undertake changes to its cannabis cultivation permitting regulations going forward, Abbott & Kindermann's expertise and knowledge of CEQA and State agencies will continue to prove useful in the County's processing of existing applications and working with CDFA. The amount of the contract is not being amended at this time.
