We are therefore requesting an amendment to the current agreement to increase the total amount by \$35,000 for a new total of \$70,000. This contractor has been retained based on its expertise in personnel-related investigations. County Counsel will process the invoices for services directly and request affected departments to reimburse County Counsel for the costs incurred.
