Recommended Action/Motion:

Direct staff to draft an urgency ordinance regarding the prohibition of water hauling from one source to another except for personal health and human safety or permitted businesses, and return to full Board for approval at a later date.

Previous Board/Board Committee Actions:

The BOS declared a drought state of emergency on April 20, 2021.

Summary of Request:

With the drought in its second year, people are increasingly concerned about wells going dry and aquifers being excessively tapped. Reports of people with private wells selling water that is then transported to distant

locations for unpermitted usages are common throughout inland Mendocino County. According to Baldwin vs. Tehama Co., counties have the authority to regulate the transfer of water. An urgency ordinance prohibiting water hauling to unpermitted business usages will help law and code enforcement to enforce and regulate the transport of water. The ordinance could contain such restrictions as limiting the hours that water trucks can operate and log of details of each delivery.
