**Recommended Action/Motion:**

Pursuant to Elections Code section 9145, either (1) repeal the ordinance adopting Chapter 22.19 - commercial cannabis activity land use development ordinance and amending Chapter 10a.17 - Mendocino cannabis cultivation ordinance and Chapter 20.242 - cannabis cultivation sites or (2) submit the ordinance to the voters at the next regular election.

**Previous Board/Board Committee Actions:**

On June 22<sup>nd</sup>, 2021, the Board of Supervisors passed and adopted Ordinance No. 4492, adopting chapter 22.18 - Commercial cannabis activity land use development ordinance and amending chapter 10A.17 - Mendocino Cannabis Cultivation Ordinance and chapter 20.242 - Cannabis Cultivation Sites.
