Summary of Request:

Mendocino County Health and Human Services Agency (HHSA), Special Investigations Unit (SIU), issued a Request for Proposals (RFP) for Security Guard Services on April 1, 2019. SIU selected American Guard Services, the top ranked vendor, to contract with HHSA. American Guard Services has contracted with HHSA for the past five Fiscal Years for guard services, and will continue these services through this new Agreement

with Social Services.

Pursuant to the proposed Agreement, American Guard Services will provide three (3) uniformed and supervised Security Guards for forty (40) hours per week at each of the following Social Services sites:

- Yokayo Social Services Campus (727/737/747 South State Street, Ukiah)
- Fort Bragg Avila Center (764/790 South Franklin Street, Fort Bragg)
- Willits Integrated Services Center, (WISC) (472 East Valley Street, Willits)
