Summary of Request:

Chabot-Las Positas Community College District (Chabot) provides evidence-based training for foster care providers, group home staff, adoptive parents and County staff serving Federal Title IV-E eligible children.

These trainings include Positive Parenting Program (Triple P), Signs of Safety (SOS) and foster parent training. Chabot contracts with local providers to manage, evaluate and document the trainings.

Funding is from the State and Title IV-E Federal funds with a required matching amount from Chabot. Trainings will include professionals, foster parents and guardians who work with foster and adoptive children within Title IV-E regulations. This training is carefully coordinated with HHSA to help build comprehensive and consistent parenting skills throughout our community to better support caretakers in raising healthy and happy children.
