Recommended Action/Motion:

Approve fourth amendment to Revenue Agreement 14-90070 with California Department of Health Care Services Substance Use Disorder Services to provide SUD services for FY 2014-17; adopt Resolution authorizing the Health and Human Services Agency Assistant Director/Behavioral Health Director to sign Revenue Agreement 14-90070 A04 and any future amendments to the Agreement that do not affect the annual maximum amount; and authorize Chair to sign same.

Previous Board/Board Committee Actions:

This agreement has been ongoing since 2007. The most recent action was the third Amendment May 17, 2016, Item 4(j).

Summary of Request:

The California Department of Health Care Services (DHCS) entered into a multi-year revenue Agreement with the County of Mendocino (Agreement 14-90070) for the purpose of providing local Substance Use Disorder (SUD) services, including alcohol and drug services, for FY 2014-2017. This fourth amendment put forth by DHCS modifies terms and conditions, and adjusts the 2016 SAPT Block Grant and State General Fund Awards. The resulting multi-year revenue total is \$3,224,937. This adjusted total is \$40,355 less than the DHCS's earlier funding estimate (made in FY 2015-16), but represents an overall increase of \$13,683 to the original three-year contract total of \$3,211,254. Mendocino County Health and Human Services Agency (HHSA) Behavioral Health and Recovery Services (BHRS) seeks Board approval to sign the amended Agreement, and adoption by the Board of a Resolution authorizing the HHSA Assistant Director/Behavioral Health Director to Sign Amendment 14-90070 A04 on behalf of Mendocino County.
