Willow Glen Care Center has several locations throughout Northern California designated to serve multiple

levels of care and behavioral health programming for adults and the elderly mentally ill. Mendocino County Behavioral Health and Recovery Services (BHRS) contracted with Willow Glen Care Center starting July 1, 2016; however the original contract did not include the Sequoia Psychiatric Treatment Center (SPTC) and Redwood Creek facility. BHRS wants to add these facilities and increase the total from \$400,000 to \$1,800,000 to meet client needs and expand residential care options.
