Summary of Request:

The applicant proposes to place a total of $200\pm$ Acres into a new Agricultural Preserve and Williamson Act Contract. The property is located West of Willits, approximately 5.5 miles on Highway 20, and 0.5 miles north. Located at 4400 W HWY 20, Willits, and consists of Assessor's Parcel Numbers 038-110-73. On November 3, 2016, the Planning Commission recommended approval of this Preserve to the Board of Supervisors. For additional information, see attached Resolution, and Planning Commission report.
