Recommended Action/Motion:

Authorize the issuance of Coastal Development Minor Use Permit, U_2016-0006 (Cimmiyotti), for a Single Unit Rental in the town of Mendocino.

Previous Board/Board Committee Actions:

Adoption of Mendocino County Code Chapter 20 "Zoning", Divisions II (Coastal) and III (Mendocino Town). This code authorizes the Coastal Permit Administrator to administratively approve certain projects without a public hearing, provided that the approval is reported to the Board of Supervisors prior to the permit becoming effective.

Summary of Request:

Coastal Development Minor Use Permit to convert a second floor 956 square-foot commercial retail use into a Single Unit Rental. The Coastal Development Minor Use Permit was administratively approved by the Coastal Permit Administrator (CPA) on January 3, 2017, and requires the Board of Supervisors authorization for
